

## COOKIE POLICY

### What Are Cookies?

Cookies are small text files, mostly letters or numbers, that are stored on your computer or mobile device when you visit a website and allow the device to be identified.

We process cookies related to visitors and users of the above-mentioned address. However, both first-party cookies (placed directly by us) and third-party cookies (placed by servers other than us) are used on the address. The types of first-party cookies we use and take responsibility for are as follows:

**Essential Cookies:** These are the mandatory cookies for the functions on the addresses to work properly and for the full fulfillment of the service offered through the address. For example, authentication cookies, which are activated when you log in to the address, ensure that your active session continues when you switch from one page to another. Disabling these cookies may render functions unavailable.

**Session Cookies:** These are temporary cookies used during your site visit and are deleted after the browser is closed. Such cookies do not contain personal data and help reduce the need for personal data to be transferred over the Internet. You can delete these cookies or prevent their use; however, disabling these cookies may result in poor Site performance and limit your user experience.

#### Google Analytics:

- **Function:** Monitoring / Analysis
- **Purpose of Use:** To measure and analyze visitor movements from different perspectives in order to increase performance and user experience.
- **Working Method:** Provides anonymous (anonymous) aggregated data about which screens you navigate and what you do in <https://www.tobbund.com.tr/>.
- **Cookie Type:** Third Party, Persistent and Session cookies
